

## International Medical Interpreters Association (IMIA) Establishes Distinction in Medical Interpreter Education Awards

The International Medical Interpreters Association (IMIA) announces the establishment of another set of IMIA Annual Awards to its cadre, the IMIA Distinction in Medical Interpreter Education Awards. This award will recognize two individuals, one representing the international training and academic environment, and the other representing interpreter training and education as done in the US. This yearly award recognizes the need for outstanding interpreter educators as role models across the country and abroad, for improved medical interpreter education. The recipient will be an educator, instructor, or language coach, and the selection will be based on concrete examples of what they have achieved and for the promise of what they will accomplish. The 2010 Awards notification will include a press release and the recipients will be announced at the IMIA Annual Conference in September of this year. The IMIA Distinction in Education Awards have the goal of being inspirational, helping us all explore the role standardization of education in the field of medical interpreting. It also promises to recognize latent talent and increase the sharing of innovative strategies that make a powerful impact on students. "The IMIA's Distinction in Medical Interpreter Education Award is a great way to acknowledge outstanding educators who have exemplified commitment, integrity, leadership and excellence in the field of medical interpreter education", stated Rose Long, Director, Bridging the Gap Interpreter Training, Cross Cultural Health Care Program, Seattle, Washington.
